I received a request from one of our regular patients to start managing her methadone treatment. Our pharmacy does not currently dispense methadone. In order to provide effective and safe care to this patient, I need to refresh my knowledge on medication-assisted treatments for opioid dependence and understand my role and responsibilities when dispensing methadone.

- I read ACP ODT guidelines
- I reviewed roles and responsibilities and tools in guidelines with pharmacy team
- I discussed policies and procedures for dilution, storage, assessment, documentation, and patient agreements with team
- Initial consult with patient on Oct 15, 2014
 - I took patient history
 - I counselled on prescribed treatment
 - I reviewed and signed two-way agreement
 - Patient understood pharmacist must assess appropriateness of therapy and witness ingestion daily
 - No carries at this time - discussed with patient
 - I used ODT guideline's "Checklist of things to do when receiving a methadone prescription"
- Over past month, I have assessed patient, witnessed daily dose, documented accordingly
 - Colleague cares for patient on weekends
- Per physician's request, provide weekly updates re: patient
