A provisional registrant is provided three attempts to successfully pass ACP's Ethics and Jurisprudence Exam, according to the <u>Pharmacists and Pharmacy Technicians Profession Regulation</u>, however the registrar may approve a fourth and final attempt. If a registrant fails their fourth and final attempt, they are no longer eligible for the pharmacist or pharmacy technician register.
