

## Required references

Pharmacies are required to have one **current** edition from each numbered category below, unless otherwise stated, in order to provide optimal patient care and pharmacy services.

Electronic comprehensive pharmacy information system databases may be used and must be current. Online or electronic versions of required reference sources are acceptable provided they mirror the hard copy and provide the same or greater information. In addition, pharmacy staff must be familiar with the use of, and be able to access, the online resource. Online or electronic resources must be available at all times in the professional area of the licensed location. Where electronic or online resources are used in a pharmacy, policies and procedures shall be in place in the event that a communication failure occurs.

All references are available from the publisher, the bookstore of a local university, or various retail outlets including online booksellers. Pharmacists should check with their chosen distributor before ordering to get the most current edition. Note that abridged versions of the below required references are **not** acceptable.
